Enclosed is a resolution 15-05 from the City of Newhalen that was passed during our February 10, 2015 meeting. We are requesting that our community be included in the Community Development Quota (CDQ) program under the Magnuson Steven Act through the North Pacific Management Council.

We are requesting to be placed on your April 2015 Meeting agenda to testify on the City of Newhalen's resolution 15-05.

Our community is located on the West side of Lake Iliamna with a population of 214 and we are currently in the 85% poverty rate. Our community is under the Kvichak River escapement for the State of Alaska and the Kvichak has the highest return of sockeye which makes our lakes and tributaries the largest sockeye spawning grounds in the world. Our community has migrated toward Bristol Bay each summer to commercial fish in Bristol Bay. We had a total of 44 drift and setnet permits for the Bristol Bay fishery but due to attrition, we now have a total of 18 drift and setnet permits in our community. Most of residents would migrate toward Bristol Bay in the summer and only a handful would stay back and watch the village. We have people who can show that they have Native Allotment selection sites for their summer camps in Bristol Bay and they can show they have ownership.

We have tried to be in the CDQ program but we do not meet the criteria of being within the 50 nautical miles of the Bering Sea. We believe that we are not represented in the selection criteria since we migrate towards the Bering Sea by going to Bristol Bay each summer months.

**WHEREAS:** The effects of the above stated opportunities will have the long term effects for the residents of this community without the benefits from the Bristol Bay Economic Development Corporation Program and the Community Development Quota Program; and,

**WHEREAS:** The City of New Stuyahok residents live Southwest Alaska which has the highest unemployment and suicide rate in the State of Alaska; and,

**WHEREAS:** The City of New Stuyahok residents are part of the 138 homeless people of the Bristol Bay Region that residing in the streets of Anchorage, Alaska; and,



RE: Request for North Pacific Fishery Management Council support to add Village of Igiugig to CDQ program

Dear Ms. Salmon:

On behalf of the North Pacific Council, and Chairman Dan Hull, I am responding to your request for our consideration of inclusion of Igiugig to the Western Alaska CDQ program. While the North Pacific Council designed the original CDQ program in the early 1990s, including the original list of eligible communities organized within six CDQ organizations, this program has since been codified in federal statute by the U.S. Congress (see Magnuson-Stevens Fishery Conservation and Management Act, Section 301(i)(1)). Eligible communities are now specifically listed as part of that Congressional statute and cannot be changed by the Council.

Your letter requests (1) that the North Pacific Council support amending the Magnuson-Stevens Act to allow the inclusion of Igiugig (or other communities) in the CDQ program, and (2) that this issue be placed on the Council's April meeting agenda for consideration. With respect to your first request, the North Pacific Council is prohibited from directly lobbying Congress, though we can respond to Congressional requests for our positions on legislation that is introduced for consideration by Congress. The Council has commented on many aspects of proposed legislation once it has been introduced in Congress for consideration, and when specifically requested to do so. Unless and until such legislation has been introduced, and we have been requested by Congress to express our position, the North Pacific Council is unable to express a position on this matter.

With regard to your second request, and for the reasons stated above, we are not able to place your request on the Council's April agenda for consideration. Additionally, we are required by law to finalize, and publish in the Federal Register, our meeting agenda at least 23 calendar days prior to the meeting. For public notice reasons, additions to that agenda can only be made for emergency situations, or for minor, informational items. As your request would represent a major policy issue for the Council, this further precludes us from placing this on our meeting agenda in April. However, I will make the Council aware of your request (as well as similar requests we have recently received from other Alaska communities), and the reasons that we cannot add this issue to our April agenda.

**Re: Request for Participation in the Western Alaska Community Development Quota Program**

Dear Chairman Hull,

Igiugig Tribal Village Council passed Resolution No. 15-17, authorizing members to petition the North Pacific Fishery Management Council to consider supporting an amendment to the Magnuson Stevens Act to allow Igiugig Tribal Village Council and the residents of the Village of Igiugig to join the Bristol Bay Economic Development Corporation and participate in the Western Alaska Community Development Quota (CDQ) Program.

According to the NOAA Fisheries website, the Western Alaska CDQ Program was created to provide western Alaskan villages "(i) ...with the opportunity to participate and invest in fisheries in the Bering Sea and Aleutian Islands Management area; (ii) to support economic development in western Alaska; (iii) to alleviate poverty and provide economic and social benefits for residents of western Alaska; and (iv) to achieve sustainable and diversified economies in western Alaska." The village of Igiugig is located on Lake Iliamna and the Kvichak River in Bristol Bay and western Alaska. Igiugig is a fishing community currently not included in the Bristol Bay Economic Development Corporation or the Western Alaska CDQ Program because the community is located more than 50 nautical miles from the coast.

However, Igiugig residents depend on all the species of wild salmon that migrate from the Kvichak headwaters to the Bering Sea for subsistence, commercial, or sport fishing.

The Western Alaska CDQ Program was designed to help western Alaska residents. Including the Igiugig Tribal Village Council and the village of Igiugig's residents in the program would only further its cause and objectives. Therefore, Igiugig Tribal Village Council respectfully requests that the North Pacific Fishery Management Council include in its April 2015 Agenda the matter of the Western Alaska CDQ including additional communities like Igiugig and allow the Igiugig Village Council to testify on these issues. Thank you for your time and consideration.

Subject: A Resolution requesting North Pacific Fishery Management Council to include Igiugig Village Council for eligibility and membership under Bristol Bay Economic Development Corporation (BBEDC) and the Western Alaska Community Development Quota (CDQ) Program.

WHEREAS, the Igiugig Tribal Village Council is a federally-recognized tribal entity authorized to cooperatively administer programs and services for the betterment of approximately 70 residents of the Western Alaska Village of Igiugig, within the Bristol Bay region;

WHEREAS, the Village of Igiugig is not located on the Gulf of Alaska coast of the North Pacific Ocean;

WHEREAS, the majority of residents of Igiugig conduct their current commercial or subsistence fishing effort in the waters of the Bering Sea;

WHEREAS, the Western Alaska Community Development Quota (CDQ) Program is an economic development program intended to provide western Alaska communities the opportunity to participate and invest in the federally managed fisheries in the Bering Sea and Aleutian Islands (BSAI), to support the economic development in western Alaska, to alleviate poverty and provide economic and social benefits for residents of Western Alaska, and to achieve sustainable and diversified local economies in western Alaska;

WHEREAS, current economic development opportunities in the Bristol Bay region are administered by the Bristol Bay Economic Development Corporation (BBEDC), which represents 17 villages in the region that are eligible to participate in the CDQ Program.

WHEREAS, substantially all of the members of least four of the BBEDC villages that are currently participating in the CDQ Program reside in areas outside of Western Alaska;

WHEREAS, Igiugig Tribal Village Council is not a member of BBEDC and is not currently eligible to participate in the CDQ Program because it is located more than 50 nautical miles from the coast, as defined by the Alaska Native Claims Settlement Act (ANCSA);

WHEREAS, the Igiugig Tribal Village Council has consistently maintained a strong interest in promoting the traditional Alaska village lifestyle for the residents of Igiugig;

WHEREAS: Igiugig residents would benefit from the education, employment, and training as well as the economic development and growth and opportunities that are available under the CDQ Program, and this is especially true in today's economic climate where state funding sources have become increasingly scarce;

WHEREAS: the Igiugig Tribal Village Council's enrollment in the program would directly promote the CDQ Program goals by supporting economic development within the region, helping to alleviate poverty

and provide economic and social benefits for the residents of Igiugig and promoting a sustainable and diversified local economy in the village;

WHEREAS: the Igiugig Tribal Village Council's economic survival is largely dependent upon its ability to participate in programs such as the CDQ Program.

NOW THEREFORE BE IT RESOLVED that the Igiugig Village Tribal Council is authorized to negotiate, execute, and administer all documents, contracts and agreements required to secure membership in the BBEDC and the CDQ Program;

BE IT FURTHER RESOLVED, that the Igiugig Village Tribal Council hereby authorizes its members to petition the North Pacific Fishery Management Council, the U.S. Secretary of Commerce and the Alaska Congressional Delegation to adopt whatever amendments necessary to render Igiugig Tribal Village Council and the Village of Igiugig's Residents eligible for participation in the CDQ Program and membership in the BBEDC.
