1.0 Introduction:

The 2020 Peter Pan Fleet Co-Op was allocated 16,550 mt of the Inshore component of the BSAI 2020 pollock TAC. The individual catcher vessels belonging to the PP Fleet CoOp were given individual percentages of the Co-Op's allocation. See Table 1-A.
